Executive Summary

USDT.z is an ERC-20–conformant token deployed on BSC with a fixed supply of 100B and 6 decimals. The contract implements 0% transfer fees and no mint function. Originally, roles were segregated into Owner, Treasury, and Pauser scopes. As of October 2025, Owner and Pauser roles have been revoked.

Tokenomics Summary

- **Fixed supply:** 100B
- **Decimals:** 6
- **Fees:** 0%
- **Pausable (disabled):** Emergency-only pause via designated Pauser.

Contract Review

- **Standards & Mixins:** ERC20, ERC20Permit, ERC20Pausable (disabled), Ownable2Step
- **Mint:** not present

- **Blacklist / maxTx:** not present
- **Pause:** originally managed by a Pauser role, now permanently disabled via on-chain revocation.

Risk Assessment & Recommendations

- **Dilution risk:** none (no mint function).
- **Role centralization:** mitigated through on-chain transparency and public disclosures.
- **Liquidity position:** LP is custodial (not locked) but governed by a public policy and disclosure framework.

Circulating Supply Methodology

Circulating Supply = totalSupply – excluded balances (treasury, burn). Owner and Pauser are no longer active.

A public **CSV registry** is maintained (GitHub Pages) to track excluded addresses and balances.

USDT.z (ticker: USDTz) is an independent BEP-20 token on BNB Smart Chain, not affiliated with Tether or with USDtez (ticker: USDTZ) on Tezos, nor with any similarly named issuer/brand. The token is designed for OTC operations and collateral use, not for speculative trading. The PancakeSwap v3 pool serves as a minimal price-discovery channel. On-chain evidence prevails over documents. This is not a financial offer.
